



Lincoln received a jolt of good news when it was announced that the U.S. Navy Blue Angels would be returning for the 2011 Guardians of Freedom Airshow.

Representatives of the Blue Angels, the Nebraska Air National Guard and Nebraska Gov. Dave Heineman joined Chamber leaders for the announcement. The year would mark the first time that the Blue Angels appeared in Lincoln since 2006.

# LINCOLN CVB AWARDED CONTRACT FOR SAE COLLEGIATE DESIGN SERIES

SAE International announced in 2012 that the Formula SAE (FSAE) California will be relocated to Lincoln Airpark. The event will be renamed Formula SAE Lincoln.

The change in venue was made, in part, because the new site offers excellent space and facility features. Lincoln Airpark has 90 continuous acres of concrete that will easily house all of the FSAE courses, team paddocks and support facilities. The size and quality of the site also provides the flexibility to revise the FSAE layout to improve the event courses, provide better team support and accommodate future growth.

Formula SAE® is a student design competition organized by SAE International. . Each student team designs, builds and tests a prototype based on a series of rules whose purpose is both to ensure onsite event operations and promote clever problem solving.







# LINCOLN AIRPARK DEVELOPMENT PLAN RELEASED

The Lincoln Airport Authority, in cooperation with the Lincoln Partnership for Economic Development, completed work on a master plan for modernization and development of its industrial park. This plan, focusing on both short and long term growth and job development will provide the Authority with a good guideline to develop the park for the benefit of the community.

The Airpark is part of the Lincoln Airport. The park has infrastructure, rail service and potential development land. The site selection consultants hired through the partnership of the organizations identified that the availability of "shovel ready" sites in the Lincoln area that had rail availability was a hindrance in job creation activities.

The Partnership is working with the Airport Authority and the City of Lincoln on developing a long-term strategy using the development plan as a guide.

# DUNCAN AVIATION EXPANSION FIRST TO BENEFIT FROM CITY FAST FORWARD FUND

On March 18, Duncan Aviation announced an expansion for its Lincoln operation. The expansion will add a new paint facility with 45,000 square feet to the existing 440,000-square-foot facility located on the east side of the Lincoln Airport. The new paint structure, costs roughly \$10.5 million to build, will allow input of some of the largest business aircraft in use today, including Gulfstream's 550, Bombardier's Global Express and Dassault's Falcon 7X.

The City of Lincoln is assisting by moving a large water main which would have been directly underneath the new hangar facility. This expansion is the first use of the City's Fast Forward Fund, which was created with Chamber support in 2009 to assist primary employers with infrastructure improvements.

"This is a great example of the importance of having these economic development tools to attract investment and create jobs," Lincoln Mayor Chris Beutler said.

Duncan Aviation-Lincoln employs roughly 1,100 employees and nearly 1,900 worldwide. The company is one of the leading organizations supporting the aviation needs of business jet operators.



# TEAMS TRAVELED TO LINCOLN FOR STATE BASEBALL

In May, Lincoln welcomed the Nebraska State High School Baseball Championships. Sixteen teams qualified for the tournament bringing over 6,000 spectators to Hawks Field at Haymarket Park, Den Hartog Field and Sherman Field.

State tournaments continue to be a focal point of the Lincoln Convention and Visitors Bureau and are an important part of this community's economy both from a direct impact and from the indirect benefit of bringing those students to the community after gradution.

# \$80 MILLION COMMITTED TO INNOVATION CAMPUS

Innovation and technology are two cornerstones on which Lincoln will build its next generation economy. They are also a significant part of the Lincoln Chamber of Commerce's economic development strategy.

The Chamber once again partnered with the University of Nebraska-Lincoln and Gov. Dave Heineman to continue to build the required infrastructure for a technology and innovation-based economy. Gov. Heineman led the effort for a one-time investment of \$25 million to accelerate the initial development of the University of Nebraska's Innovation Campus

The funding from the state will be used to kick start development and was the impedance for securing an additional \$15 million in private sector philanthropy and \$40 million from private development sources. An announcement was held at the site of the former State Fairgrounds in which the elected officials and university officials celebrated the commitment of \$80 million to Innovation Campus. The State Fair was moved in 2009 to make way for the development.

The new campus is seen as a critical component to our economic future. With the move to the Big Ten, the University of Nebraska has an outstanding opportunity to significantly increase student enrollment, expand its rapidly growing research base and develop public-private partnerships that will increase job opportunities in Lincoln.



# CHAMBER COLLABORATED FOR MEANINGFUL CIR REFORM

CIR reform was one of the toughest issues in which the Lincoln Chamber was engaged during the 2011 session of the Nebraska Unicameral. The Chamber CIR Coalition (Lincoln, Omaha and Nebraska Chambers) worked collaboratively to make this bill a reality. LB 397 represents a compromise that met objectives for comprehensive and meaningful reform. It gives elected leaders real cost containment and will get a better assessment and accounting for what taxpayers are providing in the form of the total compensation package, including benefits and health care. The bill continues to preserve collective bargaining and protect public workers.

The Chamber Coalition was invaluable to see real reform during the session. Gov. Dave Heineman was a champion for real reform, without whom is could not have been accomplished. Speaker Mike Flood, Senator Tony Fulton, and Senator Steve Lathrop were some of the key legislative players that made CIR reform a reality.

# GOVERNOR HEINEMAN SIGNED TALENT & INNOVATION BILLS

Many experts predict that future economies will be built on howhow talented the people are that make up its workforce.

Nebraska took a huge step in making sure it will be ready for the future. The Lincoln Chamber of Commerce embraced, supported and helped pass key legislation introduced by Nebraska Gov. Dave Heineman that focuses on keeping our best and brightest in the state and creating an innovative and entrepreneurial culture.

The Talent and Innovation Initiative (TI2) was a series of bills designed to make sure Nebraska remained competitive in today's global environment. The overall program included a new fund for speculative building and site development, a bill that helped Nebraska businesses fund intern positions and an angel investment tax credit to encourage more risk capital in high-growth industries.

Additionally, the bill produced the Nebraska Innovation Act which provides grants for federal research funding application and execution, prototyping of new products, commercialization of new products and grants for businesses engaged in research with Nebraska higher education institutions. Additionally, there is funding for organizations that provide assistance for small businesses.

The Lincoln Chamber has historically been at the forefront of innovation initiatives including the TI2 bills and well as the Research and Development Tax Credit and funding for Innovation Campus.



Being named a finalist for Chamber of the Year validates the hard work of the Chamber staff, the board of directors, and the many outstanding volunteers and community supporters.





# KAWASAKI EXPANDED WITH NEW RAIL CAR TESTING FACILITY AND TRACK

Lincoln Mayor Chris Beutler, Nebraska Gov. Heineman and Wendy Birdsall, president of the Lincoln Chamber and the Partnership helped Kawasaski celebrate the unveiling of its new rail car testing facility and track. The facility was the newest addition to the large Kawasaki campus in northwest Lincoln.

The rail car sector of Kawasaki's business portfolio has steady growth. With over 500 of the plant's 2,000 workers dedicated to manufacturing rail-car production, the opening of the new testing facility created the opportunity for additional contracts, helping secure jobs well into the decade. The rail car facility assembles several different types of rail cars including subway, commuter and standard passenger rail cars. Kawasaki has had several major contracts to produce cars, the most recent being the Metro contract in Washington D.C. that will produce cars until 2016.

Members of Kawasaki's executive team, invited guests and media were given the opportunity to ride on the M8 rail car during the ribbon cutting.



# NEWPORT SPOKE AT FEDERAL LEGISLATIVE SUMMIT

The Lincoln Chamber worked jointly with the Omaha, State and Bellevue Chambers to host one of the premier Public Policy events of the year. The Lincoln Chamber along with businesses, the community, and elected leaders from across the State, met with the entire federal delegation to learn about top issues affecting our nation.

The featured luncheon keynote speaker was Frank M. Newport, Ph.D., Editor in Chief of the world renowned Gallup Poll. Dr. Newport has managed and analyzed the most respected and longest running continuous monitor of American public opinion. He reports regularly for Gallup.com, USA Today, NPR, CNBC, and other media organizations. He is the author of Polling Matters: Why Leaders Must Listen to the Wisdom of the People.









#### SCCA CHAMPIONSHIPS HELD AT LINCOLN AIRPARK

The Lincoln Convention and Visitors Bureau has positioned the community as a hub for motor sports. One of the most significant of these events took place in 2011.

The Sports Car Club of America held the Tire Rack® SCCA® Solo® National Championships at the Lincoln Airport. The event, which annually attracts more than 1,200 competitors to crown National Championships in each of the Solo classes, has been held at the Lincoln Airport since 2009. Plans are to continue the event, which organizers consider a tremendous success because of the airport facilities and the support of the community.

The airport has the space to layout the event in a safe yet challenging configuration.

# INNOVATION CONNECT - A COLLABORATION OF INDUSTRY AND RESEARCH

The Lincoln Partnership for Economic Development helped organize a new industry group in Lincoln. The group is an industry-led effort to initiate collaboration between businesses and university researchers. Innovation Connect is focused on making new linkages and the eventual creation of partnerships. Meetings are intended to create dialogue about ongoing innovation, business challenges, new products in development, and possible applications of research.

Three Lincoln manufacturing and engineering related businesses began meeting with representatives from the Partnership, UNL Office of Research and NUtech Ventures. Industry organizers of the group included Bison, SourceOne, Lincoln Industries and Duncan Aviation. The membership represents 18 manufacturing firms and 7 non-profit organizations.

Innovation Connect is a direct response to this need, growing Lincoln's economy through innovation. Outcomes like new products, entry into new markets and long term sustainable job growth in Lincoln is the long-term goal.





After years of planning a city-wide community campaign and months of construction designs, Lincoln finally saw dirt move for the new Pinnacle Bank Arena. The \$179 million arena project was approved by voters in May 2010, and is expected to open in the fall of 2013. UNL basketball will be the main tenant of the 470,400-square-foot facility, which can hold nearly 15,000 fans for Husker hoops.




