- 1. Please list what you believe to be the top three issues for: a) Nebraska, and b) Your Legislative District.
 - **#1. NEBRASKA: High property taxes**

DISTRICT: Control Government spending

#2. NEBRASKA: Jobs (We need new businesses in Nebraska and better paying jobs)

	_X _ I believe our tax burden is too high and I favor cutting taxes and prioritizing our spending needs.
	I believe our tax burden is slightly excessive and favor slight tax cuts that maintain most of our current spending.
	I believe our tax burden is about what it should be in order to maintain the state and local government programs and services desired by citizens. Therefore, I do not consider tax relief as a central theme of my campaign.
	Additional Comments: Nebraska is still ranks 30 th in taxes paid by our citizens and we Need to have real economic development in Lincoln and Nebraska to increase the Revenue through new businesses and the new jobs created by them.
	State Spending
	I don't believe we need to reduce the rate of growth of state spending. Program spending in areas such as state equalization aid to K-12 schools, funding for health and human services, and other government services need to be increased and our current projected trends are reasonable. Reduced state spending leads to local property tax increases.
	I believe we need moderate reductions in the growth of state spending. Program spending in all areas can be reduced and through such shared efforts we must continue to reduce our state tax burden. Concerns over property taxes primarily should be addressed by local elected officials and administrators who make local spending decisions.
	X I believe we need fairly significant reductions in state spending. Program spending in many areas can be reduced and we must make government programs more accountable for their spending. This will require decisions about the size and scope of state

I don't pretend to have all the ideas for increasing economic development in NE However, we need to add additional incentives to the Governor's tax package Including reducing the Corporate income tax and being more transparent With our citizens so they know their tax dollars are being spent wisely. I also want to research how we can eliminate the inheritance tax and still provide replacement revenue to the counties. Nebraska is on of only eight state that impose an inheritance tax, along with the estate tax. This would help small business in the state of Nebraska. When added to the federal estate tax (that was reinstituted in 2011), Nebraska has the fifth highest tax in the nation, with 46.7 percent of inherited Wealth ultimately confiscated by government in the form of taxes. (Platte Institute Policy Study). This can't be done in one year but the debate needs to happen in the unicameral.
